With reference to the application dated 01.10.2022 subsequent school inspection in this regard, I hereby convey the grant of Recognition to Dobbs Public School, Keeranatham Road, Karattumedu, Saravanampatti Village,Coimbatore District – 641 035,Chengalpet District, Tamil Nadu for the class LKG to XII Standard for the period up to 14.10.2025 in compliance to Rule,12 of Right of Children to Free and Compulsory Education Act, 2009 and Rules 2011 and maintain the standards and norms as specified in section 19 of the 10000BBS PUBLIC SCHOOL Right of Children to Free and Compulsory Education Act, 2009.

The Recognition Code Number allotted to the School is 004–02–S–0150-1025 B. Conditional 641 035. Correspondent The above recognition is subject to the following conditions:-

- 1. The temporary recognition accorded to the school is valid up to 14.10.2025 and is to be renewed at the end of three years.
- The grant of recognition is available initially for classes LKG to XII Standard and to be extended for Secondary/ Senior Secondary classes subsequently in due course of time.

- (d) Inclusion of students with disabilities/ special need as per provision of the Persons with Disabilities Act, 2016.
- The School shall follow the syllabus on the basis of curriculum laid down by appropriate authority
- No unrecognized classes shall run within the premises of the school or in any other place in the name of School.
